PAYMENT OPTIONS

FACTS is a service offered to many Christian schools across the nation. It frees schools from the record keeping involved with accounts receivable so that schools can focus on their primary educational goals. We believe that you will be pleased with the quality of the service. Their reports are clear and accurate, and they offer friendly convenient assistance. The annual nonrefundable finance fee is \$60.00 per family.

FACTS will deduct a *Missed Payment Fee* of \$25 for each missed payment.

- 1. Full tuition payment due on or before June 12, 2009 (3% discount)**
Payment will be made directly to the school. No FACTS fee will be assessed. Discount will be forfeited if not paid by this date.
- 2. Semester tuition payment due on or before June 12, 2009 and December 4, 2009 (1.5% discount).**
Payment will be made directly to the school. No FACTS fee will be assessed. Discount will be forfeited if not paid by these dates.
- 3. 10 monthly payments through FACTS**
ALL families making monthly payments are required to use FACTS. Parents elect to pay tuition on either the 5th or 20th of each month by automatic withdrawal through the FACTS payment plan. The nonrefundable finance fee is \$60.00. First payment month is August with the last payment due in May.
- 4. Credit card payments through FACTS**
Parents may pay monthly (Option 3, 4, or 5) using Discover or MasterCard. In addition to the FACTS fee above, there will be a convenience fee for each payment (\$2.50 per \$100.00). (Example: For a tuition payment of \$400.00 per month, the convenience fee would be \$10.00.) You will be provided with a toll free number to establish this account.

STEPS TO RE-ENROLLMENT

1. Return the completed Title 1 form to the Business Office by February 13th.
2. Complete re-enrollment form and submit to the Business Office.
3. Submit by check or cash to the Business Office a payment of \$150 per re-enrolled student. Re-enrollment is complete when the Business Office receives the completed form and the payment.
