NEW SCHOLARSHIPS AVAILABLE:

Warner Christian Academy now has three new scholarships available. Please note that families wishing to apply for these new scholarships must inform the Student Finance Department by July 31 of each year to ensure proper enrollment in the programs. Scholarships may not be combined.

- ❖ **New Active-Duty Scholarship:** A \$500 scholarship is offered to parents who work full-time (active-duty) in the following professions: military, law enforcement, firefighters, nurses, paramedics.
- ❖ **New Pastoral Scholarship:** Ordained Pastors /Missionaries will receive a 50% off scholarship on the remaining balance after Step Up for Students (SUFS) or Educational Market Assistance (EMA) is applied.
- ❖ **New Legacy Scholarship:** A \$500 scholarship is offered to parents who are WCA alumni (graduated from WCA).

EDUCATIONAL MARKET ASSISTANCE (EMA) OR STEP UP FOR STUDENTS (SUFS)

STEP 1: Apply or Renew Scholarships with Educational Market Assistance (EMA) or Step Up for Students (SUFS)

This information is provided as a courtesy and is a separate application process from WCA's. These funds are tax dollars that now follow the student and are available to EVERY Student. Per the EMA/ SUFS website, the steps outlined below will help you navigate how to apply and please note that errors when applying can lead to potential delays.

NEW FAMILIES:

STILL NEED ASSISTANCE?

STEP 2: Apply for WCA Financial Aid (available to qualifying families (limited funds)):

This program is limited and requires a new application to be filed annually to be considered for funding. Eligibility is based in part on income and financial need. Applications will be accepted using an independent service provider and must be submitted by August 30 of each year and require a copy of your 2023 tax return. Details are available in your FACTS family portal under the financial tab, by clicking on "Apply for Grant & Aid".
